**RESCISSION OF NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR SAHM BROADWAY PROPERTY, LLC (FORMER ELIXIR INDUSTRIES), 18037 SOUTH BROADWAY, GARDENA, CA. (NPDES NO. CA0062537, CI NO. 7104)**

Our letter dated March 25, 2008, enclosed a copy of a tentative Order which would rescind the subject requirements and NPDES permit.

Pursuant to Division 7 of the California Water Code, the Regional Board, at a public hearing held on May 1, 2008, reviewed the tentative Order, considered all factors in the case, and adopted Order No. R4-2006-0026 (copy attached) relative to the rescission of Order No. R4-2003-0149 (NPDES No. CA0062537).

Should any future activities at the subject site result in discharges of wastewater to surface waters, you are required to file a Report of Waste Discharge with this Regional Board prior to discharge as a permit application.

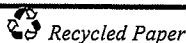

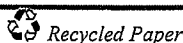
