TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—PICO WATER DISTRICT, VARIOUS WELLS DISCHARGING TO SAN GABRIEL RIVER WATERSHED, PICO RIVERA, CALIFORNIA (NPDES NO. CAG994005, CI-7317)

Dear Mr. Grajeda:

The subject discharge is regulated under Order No. R4-2003-0108, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges of Groundwater from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003.


We have reviewed your June 30, 2011, letter requesting termination of your coverage under the General Permit. The letter indicated that discharge at the above-referenced project has stopped and that the subject NPDES permit is no longer needed.

On January 27, 2012, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to the storm drain. Since there is no discharge of groundwater from the facility, coverage under Board Order R4-2003-0108, General NPDES Permit No. CAG994005, for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
