## CONTINUATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – THE BOEING COMPANY, 2401 E. WARDLOW ROAD, LONG BEACH, CALIFORNIA (NPDES NO. CAG994003, CI–7613)

We have completed our review of your Notice of Intent (NOI) and analytical results of representative wastewater samples that you submitted in order to continue enrollment under the General NPDES Permit. Discharge of non-contact cooling water at the above-referenced facility is currently regulated under NPDES General Permit No. CAG994003 (Order No. 98-055) adopted by this Board on June 29, 1998.

Based on the attached Fact Sheet and other information provided, we have determined that the wastewater discharge meets the conditions to be regulated under Order No. R4-2004-0058, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Nonprocess Wastewater to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on April 1, 2004. Your existing enrollment under NPDES Permit No. CAG994003, Order No. 98-055, which was issued to you on February 28, 2000, is superseded by this new permit that terminated your coverage under Order No. 98-055.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order No. R4-2004-0058 and Monitoring and Reporting Program No. CI-7613. The discharge limitations in Part E.1.a. and b of Order No. R4-2004-0058 for the specific constituents listed on the Table with the enclosed Fact Sheet are applicable to your discharge. The wastewater from the facility discharges into a nearby storm drain that flows into the Los Cerritos Channel, thence to Alamitos Bay, a Miscellaneous Los Angeles County Coastal Stream. Therefore, the discharge limits in Attachment B of Order No. R4-2004-0058 are not applicable to your discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, <u>ATTN: Information Technology Unit.</u> When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-7613 and NPDES No. CAG994003", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.

In order to avoid future annual fees, please submit written notification when the project has been completed and the permit is no longer needed.
