CONTINUATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – SOUTHERN CALIFORNIA WATER COMPANY, GAGE WELLS # 1 AND # 2, 6112 E. GAGE AVENUE, BELL GARDENS, CALIFORNIA (NPDES NO. CAG994005, CI-8184)

We have completed our review of your Notice of Intent (NOI) and analytical results of representative groundwater samples submitted in order to continue enrollment under the General NPDES Permit. Discharge of groundwater generated from the above-referenced facility is aurrently regulated under NPDES General Permit No. CAG994002 (Order No. 97-043) adopted by this Board on May 12, 1997.

Based on the attached Fact Sheet and other information provided, the proposed discharge of groundwater meets the conditions to be regulated under Order No. R4-2003-0108, General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Las Angeles and Ventura Counties, adopted by this Board on August 7, 2003. Your existing enrallment under NPDES Permit No. CAG994002, Order No. 97-043, which was issued to you on August 31, 2000, is superseded by this new permit that terminated your coverage under Order No. 97-045.

Endosed are your Waste Discharge Requirements, which also serve as a NPDES permit, consisting of Order No. R4-2003-0108 and Monitoring and Reporting Program No. CI-8184. The discharge limitations in Part E.1 of Order No. R4-2003-0108 are applicable to your discharge. Discharge from the project drains to the Las Angeles River; therefore, the discharge limitations in Attachment B.7.d. are applicable to your discharge. Prior to starting discharge, a representative sample of the effluent shall be obtained and analyzed to determine compliance with the discharge limitations.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit.

When submitting monitoring or technical reports to the Regional Board per these requirements, please induce a reference to "Compliance File No. CI-8184 and NPDES No. CAG994005", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your manitoring reports. Submit each type of report as a separate abaument. In order to avoid future annual fees, please submit written notification when the project has been completed and the permit is no longer needed.

We are sending a copy of Order No. R4-2003-0108 only to the applicant. For those on the mailing list, please refer to the Board Order previously sent to you.
