

REVISED GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT (NPDES) AND WASTE DISCHARGE REQUIREMENTS – CITY OF SANTA PAULA, CITY WELL NOS. 1B, 12, 13, & 14, SANTA PAULA, CALIFORNIA (NPDES NO. CAG994005, CI-8292)

In our letter dated December 1, 2003, we authorized the discharge of potable well development wastewater from the above-referenced facilities under General Permit NPDES No. CAG994005, Order No. R4-2003-0108; Waste Discharge Requirements for Discharges of Groundwater From Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on August 7, 2003.

We have received and reviewed your April 18, 2006, submittal requesting this Board to include the discharge of groundwater from redevelopment and/or startup of pumping from water Well No. 12 under your coverage for the above referenced general permit. We have no objection to you including the proposed discharge from this well under the general permit.

The discharge limitations in Part E.1. Order No. R4-2003-0108 for the specific constituents listed on the Table with the enclosed Fact Sheet are applicable to your discharge. Discharge from the project drains to Santa Clara River between A Street, Fillmore and Freeman Diversion "Dam" near Saticoy; therefore, the discharge limitations in Attachment B.3.f. of Order No. R4-2003-0108 are applicable to your discharge. Prior to starting discharge, a representative sample of the effluent shall be obtained and analyzed to determine compliance with the discharge limitations.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order No. R4-2003-0108 and revised Fact Sheet and Monitoring and Reporting Program (MRP) No. CI-8292. All monitoring reports should be sent to the Regional Board, <u>ATTN: Information Technology Unit.</u> When submitting monitoring and technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-8292 and NPDES No. CAG994005", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine your discharge monitoring reports with other reports. Submit each type of report as a separate document.
