CONTINUATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – BP WEST COAST PRODUCTS LLC, HATHAWAY TERMINAL, 2350 OBISPO AVENUE, SIGNAL HILL, CALIFORNIA (NPDES NO. CAG674001, CI-8306)

We have completed our review of your Notice of Intent (NOI) and analytical results of representative samples that you submitted in order to continue enrollment under the General NPDES Permit. Discharge of hydrostatic test water at the above-referenced facility is currently regulated under NPDES General Permit No. CAG674001 (Order No. 97-047) adopted by this Board on May 12, 1997.

Based on the attached Fact Sheet and other information provided, we have determined that the wastewater discharge meets the conditions to be regulated under Order No. R4-2004-0109, General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on July 1, 2004. Your existing enrollment under NPDES Permit No. CAG674001, Order No. 97-047, which was issued to you on August 20, 2001, is superseded by this new permit that terminated your coverage under Order No. 97-047.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order No. R4-2004-0109 and Monitoring and Reporting Program No. CI-8306. The discharge limitations in Part E.1. of Order No. R4-2004-0109 are applicable to your discharge. The hydrostatic test water discharge flows into the Los Cerritos Channel, thence to the Alamitos Bay, a Miscellaneous Los Angeles County Coastal Stream. Therefore, the discharge limitations in Attachment B of Order No. R4-2004-0109 are not applicable to your discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-8306 and NPDES No. CAG674001", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.

California Environmental Protection Agency

In order to avoid future annual fees, please submit written notification when the project has been completed and the permit is no longer needed.
