I. REPORTING REQUIREMENTS

A. The Discharger shall implement this monitoring program on the effective date of this enrollment (July 8, 2002) under Regional Board Order No. R4-2002-0030. The first monitoring report under this Program is due by July 15, 2002.

Monitoring reports shall be received by the dates in the following schedule:

Reporting Period	<u>Report Due</u>
January – March	April 15
April – June	July 15
July – September	October 15
October – December	January 15

- B. If there is no discharge or injection, during any reporting period, the report shall so state. Monitoring reports must be addressed to the Regional Board, Attention: Information Technology Unit.
- C. By March 1 of each year, the Discharger shall submit an annual summary report to the Regional Board. The report shall contain both tabular and graphical summaries of the monitoring data obtained during the previous calendar year. In addition, the Discharger shall discuss the compliance record and the corrective actions taken or planned, which may be needed to bring the discharge into full compliance with the waste discharge requirements.
- D. The Discharger shall comply with requirements contained in Section G of Order No. R4-2002-0030 "*Monitoring and Reporting Requirements*" in addition to the aforementioned requirements.

II. HYDROGEN RELEASE COMPOUND (HRC) INJECTION MONITORING REQUIREMENTS

The quarterly reports shall contain the following information regarding injection activities:

- 1. Location Map showing barriers and injection points for the HRC:
- 2. Written summary defining:
 - Depth of injection points;
 - Quantity of HRC injected per injection point and per vertical spacing at point;
 - Total amount of HRC injected at site; and
 - Verification of HRC compound injected.

III. GROUNDWATER MONITORING PROGRAM

A groundwater monitoring program shall be designed to detect and evaluate impacts associated with the HRC injection activities. The following shall constitute the monitoring program for Monitoring Well Nos. MW-14-D1, MW-14-D2, MW-14-D3, MW-14-S1, MW-14-S2, MW-14-S3, MW-14-S4, MW-14-S5, MW-14-S6, MW-14-S7, MW-14-S8, and MW-14-S9 (Figure 5-1). The Discharger shall conduct initial sampling from all the monitoring wells for the following groundwater parameters prior to the injection of any HRC materials and then as required below:

All groundwater monitoring reports must include, at minimum, the following:

- a. Well identification, date and time of sampling;
- b. Sampler identification, and laboratory identification;
- c. Quarterly observation of groundwater levels, recorded to 0.01 feet mean sea level and groundwater flow direction.

Each report shall contain the following completed declaration:
