COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS – ARDEN REALTY, INC., WILSHIRE-SAN VICENTE PLAZA, 8383 WILSHIRE BOULEVARD, BEVERLY HILLS, CALIFORNIA (NPDES NO. CAG994001, CI-8463)

Dear Ms. McGregor:

Discharge of groundwater from the Wilshire-San Vicente Plaza is currently regulated under the National Pollutant Discharge Elimination System (NPDES) Permit No. CAG834001, Order No. 97-046, and Monitoring & Reporting Program No. CI-7406. In March 1997, this Regional Board granted closure for the remediation of petroleum impacted groundwater at the site. However, Arden Realty, Inc. has continued operation of the groundwater extraction wells to lower the water table beneath the facility. In a letter dated September 3, 2002, Arden Realty, Inc. requested to terminate the current permit which is no longer appropriate for the site, since treatment is not necessary for the permanent dewatering activities at the site.

We have reviewed the groundwater quality report dated July 30, 2002, and the NPDES application package submitted, and determined that the discharge of groundwater from the dewatering activities at the subject site should be regulated under NPDES Permit No. CAG994001, Order No. 97-045, General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by the Board on May 12, 1997. The existing NPDES Permit No. 834001 (Order No. 97-046) which was issued to Arden Realty, Inc. on June 30, 1997, for the groundwater cleanup project, is superseded by this new permit, and your coverage under Order No. 97-046 will be terminated in a separate letter.

Enclosed are your Waste Discharge Requirements, which also serve as your General NPDES permit, consisting of Order No. 97-045 and a revised Monitoring and Reporting Program No. Cl-8463. The discharge limitations in Part E and Attachment B of Order 97-045 are applicable to your discharge. The groundwater discharge from the site drains into the Ballona Creek, therefore, the discharge limitations in Attachment A are not applicable to your discharge. Prior to starting discharge, a representative sample of the groundwater shall be obtained and analyzed to determine compliance with the discharge limitations.

Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.

We are sending Board Order No. 97-045 only to the applicant. For those on the mailing list, please refer to the Board Order previously sent to you. A copy of the Order will be furnished to anyone who requests it.
