RESCISSION OF THE GENERAL WASTE DISCHARGE REQUIREMENTS (WDR) PERMIT (WDR ORDER NO. R4-2002-0030 (SERIES NO. 7)), MONITORING AND REPORTING PROGRAM CI-8494, BOEING REALTY CORPORATION, FORMER C-6 FACILITY, 19503 SOUTH NORMANDIE AVENUE, LOS ANGELES, CALIFORNIA (FILE NO. 95-036, SLIC NO. 0410; SITE ID 1846000)

Dear Mr. Scott:

We have received the "Final Report of In-Situ Reactive Zone Pilot Test at Former Building 2" (Report) dated March 29, 2007, prepared by your consultant Camp Dresser & Mckee (CDM). The report was submitted to comply with the Monitoring and Reporting Program (MRP) CI-8494. The report summarizes the results of bioremediation amendment injection and groundwater monitoring activities performed to date at the Former C-6 Facility, Building 2 Area. As indicated in the Report, the last injection activities occurred in 2004 and quarterly groundwater monitoring has been ongoing. No additional injection activities are anticipated to be conducted under this permit. This Regional Board is currently in the process of adopting a new site specific WDR for the injection activities to be conducted at the Former C-6 Facility. Therefore, any additional injection activities to be conducted in the Building 2 Area will be covered under the new site specific WDR.

This letter serves as a rescission letter for the existing General WDR, Order No. R4-2002-0030 and MRP No. CI-8494, for the subject site. You must submit a new revised workplan for any new injection activities to be completed in the Building 2 Area. Please transfer the WDR groundwater monitoring wells into the site wide groundwater monitoring program and continue to sample these wells accordingly.
