ORDER NO. R4-2019-0050 TERMINATING INDIVIDUAL WASTEWATER DISCHARGE REQUIREMENTS FOR THE FOLLOWING FACILITIES:

- MALIBU COUNTRY MART I, 3835 CROSS CREEK ROAD, MALIBU, CA 90265 (ORDER NO. R4-2003-0029, CI NO. 8518, FILE NO. 00-075, GLOBAL ID WDR100000441)
- MALIBU COUNTRY MART II, 23410 CIVIC CENTER WAY, MALIBU, CA 90265 (ORDER NO. R4-2003-0031, CI NO. 6325, FILE NO. 76-044, GLOBAL ID WDR100000447)
- MALIBU COUNTRY MART III, 3900 CROSS CREEK ROAD, MALIBU, CA 90265 (ORDER NO. R4-2002-0196, CI NO. 8512, FILE NO. 00-074, GLOBAL ID WDR100000443)

Dear Mr. Koss:

The Los Angeles Regional Water Quality Control Board (Regional Water Board), is the public agency with primary responsibility for the protection of ground and surface water quality for all beneficial uses within major portions of Los Angeles and Ventura Counties. The three (3) facilities mentioned above are located within the Regional Water Board's jurisdiction.

On January 30, 2003, February 4, 2003, and November 25, 2002, the Regional Water Board adopted separate Waste Discharge Requirements (WDRs) Order Nos. R4-2003-0029, R4-2003-0031, and R4-2002-0196, respectively, for the discharge of wastewater to land from on-site wastewater disposal systems (OWDSs) at Malibu County Mart I located at 3835 Cross Creek Road, Malibu County Mart II at 23410 Civic Center Way, and Country Mart III at 3900 Cross Creek Road in the City of Malibu (City). These individual WDRs required the discharge to meet effluent limitations and groundwater quality objectives in order to protect the water quality of the Malibu Valley Groundwater Basin and public health.

On November 5, 2009 the Regional Water Board adopted Resolution No. R4-2009-007 approving an amendment to Chapter 4 of the Water Quality Control Plan for the Coastal Watersheds of Los Angeles and Ventura Counties (Basin Plan), to prohibit OWDSs in the Malibu Civic Center Area (Basin Plan Amendment). The Basin Plan Amendment required that all commercial discharges to OWDSs in the Malibu Civic Center Area cease by November 5, 2015. In August 2011, the Regional Water Board, the State Water Resources Control Board, and the City entered into a Memorandum of Understanding, which was subsequently revised on December 4, 2014 and February 2, 2017, for the City to construct and startup the Malibu Civic Center Wastewater Treatment Facility (MCCWTF) and connect commercial properties within the Phase I boundaries,

including Malibu Country Marts I, II, and III, by September 30, 2018. On October 30, 2018, the City reported that the wastewater generated from these three facilities was diverted to the MCCWTF before the September 30, 2018 deadline. Therefore, the three individual WDRs identified above as Order Nos. R4-2003-0029, R4-2003-0031, and R4-2002-0196 are no longer needed because there are no wastewater discharges to land from the OWDSs at Malibu Country Marts I, II and III.

Our letter of February 8, 2019 transmitted tentative Termination Order for Malibu Country Marts I, II and III. Pursuant to Division 7 of the California Water Code, the Regional Water Board at a public meeting held on April 11, 2019, reviewed the tentative Termination Order, considered all factors in the case, and adopted Termination Order No. R4-2019-0050 (copy enclosed) relative to these discharges.

ORDER NO. R4-2019-0050 TERMINATION OF INDIVIDUAL WASTE DISCHARGE REQUIREMENTS ISSUED TO DISCHARGERS IDENTIFIED AS PHASE I PROPERTIES IN THE MALIBU CIVIC CENTER ONSITE WASTEWATER DISPOSAL SYSTEMS (OWDS) DISCHARGE PROHIBITION AREA

The California Regional Water Quality Control Board, Los Angeles Region (Regional Board) finds:




Figure 1 – Malibu Civic Center Area

- 1. The Malibu Civic Center Area (Figure 1) is defined as the area within the lower Winter Canyon watershed, Malibu Valley watershed, and adjacent coastal strips between and including Amarillo Beach and Surfrider Beach.
- 2. Prior to January 2018, there were neither sewer lines nor publicly-owned treatment works to transport or treat domestic wastewater generated in the Malibu Civic Center Area. Between December 2000 and June 2015, the Regional Board issued seven individual Waste Discharge Requirements (WDRs) listed in Table 1 to regulate the discharges of wastewater from Onsite Wastewater Disposal Systems (OWDS) located within the Malibu Civic Center Area:

- 3. On November 5, 2009 the Regional Board amended Chapter 4 of the Water Quality Control Plan for the Coastal Watersheds of Los Angeles and Ventura Counties (Basin Plan) to prohibit discharges from OWDS in the Malibu Civic Center Area (Regional Board Resolution No. R4-2009-007).
- 4. The Basin Plan Amendment prohibits all new OWDS in the Malibu Civic Center Area and prohibits the discharge from existing commercial properties by November 5, 2015 and from residential properties by November 5, 2019.
- 5. In August 2011, the Regional Board, the State Water Resources Control Board (State Water Board), and the City of Malibu (City) entered into a Memorandum of Understanding (MOU), which was subsequently revised on December 4, 2014 and February 2, 2017, for the City to construct and operate the Malibu Civic Center Wastewater Treatment Facility (MCCWTF) and connect commercial properties within the Phase I boundaries by September 30, 2018.
- 6. On March 12, 2015, the Regional Board adopted Waste Discharge Requirements/Water Reclamation Requirements (WDRs/WRRs) for the MCCWTF for the discharge of tertiarytreated wastewater and recycled water application. The City completed construction of the MCCWTF in September 2018 and connected all commercial facilities identified in the Phase I area to the MCCWTF.
- 7. On October 30, 2018, the City provided a list of all Phase I facilities that are connected to the MCCWTF. There are 34 facilities with OWDS, including seven commercial facilities that have been issued individual WDRs as listed in Table 1 above, three facilities enrolled under Regional Board or State Water Board General WDRs, and 24 facilities regulated locally by the City of Malibu.
- 8. The wastewater generated at these commercial properties is now discharged to the MCCWTF for treatment; and existing OWDS for these dischargers are no longer in use. The seven commercial properties subject to individual WDRs for OWDS discharges, listed in Table 1 above, are no longer discharging waste from the OWDS. Therefore, the individual WDRs for these OWDS are not needed and may be terminated.

- 9. The purpose of this Order is to terminate the individual WDRs for these seven Dischargers, including Order Nos. 00-182, 01-010, R4-2002-0196, R4-2003-0029, R4-2003-0031, R4-2008-0211, and R4-2015-0118.
- 10. Petition Any person aggrieved by this action of the Regional Board may petition the State Water Board to review the action in accordance with California Water Code section 13320 and California Code of Regulations title 23, sections 2050 and following. The State Water Board must receive the petition by 5:00 p.m., 30 days after the date of this Order, except that if the thirtieth day following the date of this Order falls on a Saturday, Sunday, or a state holiday, the petition must be received by the State Water Board by 5:00 pm on the next business day. - 11. **Public Notice** On February 8, 2019, the Regional Board informed the dischargers individually of its intent to prepare an order to terminate the subject individual WDRs listed in Table 1 above because there is no discharge from OWDS at the identified facilities and the individual WDRs are no longer needed. On March 1, 2019, the Regional Board notified the City, dischargers, and other interested agencies and persons of the tentative Order No. R4-2019-0050 terminating the seven (7) individual WDRs specified in Table 1 above and has provided an opportunity to submit written comments on the tentative Order.

The Regional Board, in a public meeting, heard and considered all comments pertaining to Order No. R4-2019-0050.

IT IS HEREBY ORDERED that the following Orders are terminated except for enforcement purposes:

- Order No. 00-182;
- Order No. 01-010;
- Order No. R4-2002-0196;
- Order No. R4-2003-0029;
- Order No. R4-2003-0031;
- Order No. R4-2008-0211; and
- Order No. R4-2015-0118.
