**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS— CITY OF CERRITOS, CORPORATE YARD, 16540 MARQUARDT AVENUE, CERRITOS, CALIFORNIA (NPDES NO. CAG914001, CI-8522)**

Dear Mr. Kellam:

In our letter dated October 2, 2007, we informed you that the subject discharge is regulated under Order No. R4-2007-0022, *Waste Discharge Requirements for Treated Groundwater from Investigation and/or Cleanup of Volatile Organic Compounds Contaminated-Sites to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On July 18, 2012, Environ Strategy Consultants, on behalf of City of Cerritos requested the Regional Board to terminate coverage under the above-referenced General NPDES permit for the subject facility. City of Cerritos ceased operations of the groundwater treatment system and all associated discharges on June 23, 2009.

On August 13, 2012, Regional Board staff inspected the subject facility and verified that there is no discharge of groundwater from the groundwater treatment system to surface water. Therefore, coverage under Board Order No. R4-2007-0022 for the subject facility is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface water or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate Waste Discharge Requirements.
