

GENERAL WASTE DISCHARGE REQUIREMENTS FOR SMALL COMMERCIAL AND MULTIFAMILY RESIDENTAL SUBSURFACE SEWAGE DISPOSAL SYSTEMS – UNITED ROCK HOT MIX ASPHALT PLANT, 2600 E. BUENA VISTA STREET, IRWINDALE, CALIFORNIA (FILE NO. 02-207, CI-8563)

We have completed our review of your application for Waste Discharge Requirements for discharge from the septic disposal system at the above mentioned facility owned by Blue Diamond Materials, a Division of Sully Miller Contracting Company (Figure 1). A two-story, 960 square feet Control Building has been constructed at the facility. The upper story houses machinery and equipment for control of the plant operation. The lower story has a storage area and a bathroom facility. The bathroom facility consists of one water closet, one urinal, and one wash basin.

According to the Los Angeles County Public Works Sewer Maintenance Department, there are no sanitary sewer lines within 2,000 feet of the site. Due to the distance from the sewer lines, to connect the facility to the sewer would be economically prohibitive. A septic disposal system will therefore be installed for the bathroom facility. The proposed septic disposal system will consist of a 750-gallon septic tank connected to a 15-foot deep, 4-foot diameter seepage pit (Figure 2). The average number of people using the bathroom will be three and the expected flow rate from the bathroom is estimated at 75 gallons per day (gpd).

Regional Board staff have reviewed the information provided and have determined that the proposed discharge meets the conditions specified in Order No. 01-031, "General Waste Discharge Requirements for Small Commercial and Multifamily Residential Subsurface Sewage Disposal Systems," adopted by this Regional Board on February 22, 2001.

Enclosed are your Waste Discharge Requirements, consisting of Order No. 01-031 and Monitoring and Reporting Program No. CI-8563.

The "Monitoring and Reporting Program" requires you to implement the monitoring program on the effective date of coverage under this permit. The Regional Board Executive Officer (Executive Officer) at his discretion may require you to develop a groundwater monitoring program. If this decision is made, you must submit a workplan to implement the groundwater monitoring program within 45 days of such notification. The workplan is subject to approval by the Executive Officer. Once approved it must be implemented within 60 days (See section III
