

GENERAL WASTE DISCHARGE REQUIREMENTS IN-SITU BIOREMEDIATION COVERAGE (ORDER NO. R4-2002-0030: SERIES 024) REMEDIATION PILOT STUDY, FORMER COMPTON SITE, BOEING REALTY CORPORATION (SLIC 559, 558, and 462)

Dear Mr. Mossman:

We have completed our review of "General Waste Discharge Requirements (WDR) Permit Application, Enhanced In-Situ Bioremediation, The Boeing Company, Former Compton Site, Compton, CA" (Application) submitted April 1, 2003 and Addendum No. 1 to the Application (Addendum) submitted June 5, 2003 to inject a carbohydrate solution into groundwater at the subject site for use in in-situ bioremediation pilot tests to address the volatile organic compounds (VOCs) in groundwater.

Boeing Realty Corporation proposes to conduct pilot tests at the Former Compton Site (Site) to evaluate the effectiveness of enhancing bioremediation of the VOCs by injecting a carbohydrate solution (consisting of 10% to 20% molasses) into the groundwater and create an "in situ reactive zone" increasing the number of microorganisms and accelerating the rate of biodegradation. On February 26, 2003, the Regional Board approved the "Former Compton Site In-Situ Reactive Zone Pilot Test Workplan" (Workplan) dated February 3, 2003.

Regional Board staff have reviewed the information provided and have determined that the proposed discharge meets the conditions specified in Regional Board Order No. R4-2002-0030, "General Waste Discharge Requirements for Groundwater Remediation at Petroleum Hydrocarbon Fuel and/or Volatile Organic Compound Impacted Sites," adopted by this Regional Board on January 24, 2002. Refer to attached fact sheet.

Enclosed are your Waste Discharge Requirements, consisting of Regional Board Order No. R4-2002-0030 (Series 024) and Monitoring and Reporting Program No. CI-8586. Please note that the discharge limits in Attachment A (DWR Basin No. 4-11 (Central Basin)) of this Order No. R4-2002-0030 are applicable to your discharge.

The "Monitoring and Reporting Program" requires you to implement the monitoring and reporting program on the effective date of this enrollment under Regional Board Order No. R4-2002-0030. All monitoring reports shall be sent to the Regional Board, <u>ATTN: Information Technology Unit.</u>
