**TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS  
– MASTER SUN CLEANERS, 2405 WEST ROSECRANS AVENUE, GARDENA,  
CALIFORNIA (ORDER NO. R4-2002-0030, SERIES NO. 028, CI-8606, GLOBAL ID NO.  
WDR100000007)**


Dear Mr. Rodd,

On October 24, 2003, this Regional Water Quality Control Board (Regional Board) informed you that the subject discharge is regulated under Regional Board Order No. R4-2002-0030, which specifies your Waste Discharge Requirements (WDR).

Based on groundwater data collected in June 1998, tetrachloroethylene (PCE) was detected at concentrations up to 63,000 micrograms per liter ( $\mu\text{g/L}$ ). From 2004 to 2016, groundwater remediation activities were conducted by injecting hydrogen release compound and carbon sources/electron donors for enhanced in situ bioremediation. The March 2016 sampling results indicated that PCE, trichloroethylene, and cis-1,2-dichloroethylene were detected in groundwater at concentrations of 14  $\mu\text{g/L}$ , 23  $\mu\text{g/L}$ , and 27  $\mu\text{g/L}$  respectively. Therefore, Regional Board Site Cleanup Program issued no further action determination letter for the subject site on February 7, 2017.

In the letter dated February 13, 2017, you requested termination of the WDR coverage under Regional Board Order No. R4-2002-0030 because all the injection activities were completed in February 2016. The coverage under Regional Board Order No. R4-2002-0030 for the subject facility is no longer needed and hereby terminated with the exception of enforcement under the term of the permit.
