TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—EATON CORPORATION, FORMER EATON FACILITY, 31717 LA TIENDA DRIVE, WESTLAKE VILLAGE, CALIFORNIA (NPDES NO. CAG994004, CI-8640)

In our letter dated June 21, 2005, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, Waste Discharge Requirements for *Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.


We have received and reviewed your June 28, 2007 letter, requesting termination of your coverage under the General Permit. The letter indicated that you have completed the subject project and have ceased discharging groundwater from the project site.

On October 30, 2008, Board staff inspected the project site and verified that there is no discharge of groundwater from the project site to the storm drain. Since there is no discharge of groundwater from the project site, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004, for the subject project is hereby terminated except for enforcement purposes.

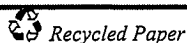

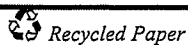
