TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – RUBIO CANON LAND AND WATER ASSOCIATION WELL NO. 7 PUMP TESTING & START-UP TEST, 265 W. FIGUEROA DRIVE, ALTADENA, CALIFORNIA (NPDES NO. CAG994005, CI-8655)

In our letter dated October 8, 2003, we informed you that the subject discharge is regulated under *Waste Discharge Requirements for Discharges of Groundwater From Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

We have received and reviewed your November 30, 2005 letter, requesting termination of coverage under General NPDES Permit No. CAG994005 (Order No. R4-2003-0108) for the subject project. The letter indicated that the one-time discharge of groundwater from the development of potable well No. 7 has been completed.

On December 1, 2005, Board staff inspected the facility and verified that there is no discharge of groundwater from the subject site to storm drain. Since there is no discharge, coverage under Board Order No. R4-2003-0108, NPDES Permit No. CAG 994005 is hereby terminated, except for enforcement purposes.

Please note that if future discharge of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain waste discharge requirements.
