## APPROVAL OF MONITORING PLAN UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS – WESTLAKE LAKE MANAGEMENT ASSOCIATION, WESTLAKE LAKE, CALIFORNIA (NPDES NO. CAG990004, CI-8784)

We have received and reviewed your *Water Quality Monitoring Program and Quality Assurance Project Plan* (Monitoring Plan) that you submitted to comply with Order No. 2004-0008-DWQ, *Statewide General National Pollutant Discharge Elimination System Permit For Discharges of Aquatic Pesticides to Surface Waters of the United States for Vector Control*, adopted by the State Water Resources Control Board (State Board) on May 20, 2004.

The Monitoring Plan is hereby approved for implementation. We anticipate that, as experience with implementation of this Monitoring Plan grows, it may become necessary to modify the Monitoring Plan to make it more effective and efficient.

Please be aware that you are required to submit each calendar year an Annual Report to the Regional Board by January 31 of the following year, as specified in section C. of Attachment B of the subject NPDES permit. The first Annual Report is due by January 31, 2005. When submitting the annual report to the Regional Board per the requirements of this permit, please include a reference to "Compliance File No. CI-8784 and NPDES No. CAG990004", which will assure that the reports are directed to the appropriate file and staff. Also, please submit each type of report as a separate document.

If you cease the application of pesticides and the permit is no longer needed, please submit written notification to the Regional Board so that you will not be billed for future annual fees.
