
TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—SNYDER-MASSELIN VENTURE, L.P., OFFICE DEPOT, 5665 WILSHIRE BOULEVARD, LOS ANGELES (CAG994004, CI-8791)

In our letter dated July 27, 2004, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, *General NPDES and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On November 27, 2007, you informed Regional Board staff that the above-referenced project was completed in January 2006. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On November 28, 2007, our staff inspected the facility and verified that there is no discharge to the storm drain.

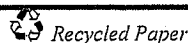

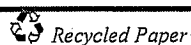
