GENERAL WASTE DISCHARGE REQUIREMENTS FOR SMALL COMMERCIAL SUBSURFACE SEWAGE DISPOSAL SYSTEMS – KIDS' KORRAL, 2586 BLANCHARD ROAD, CAMARILLO, CALIFORNIA (FILE NO. 05-058 CI-8884)

We have completed our review of your application, dated March 14, 2005, for Waste Discharge Requirements to discharge domestic wastewater from Kids' Korral, in the City of Camarillo.

The Kids' Korral (Discharger) operates approximately eight fenced acres known as Blanchard Road at the above-mentioned location. The Kids' Korral is dedicated to improving the quality of life for children within the autism spectrum by providing an agricultural ranch setting with sensory, educational, and socialization opportunities. The site is located in unincorporated Ventura County in the Santa Rosa Valley. Groundwater beneath the site is estimated to be present at a depth of approximately 40 feet below ground surface. According to Mr. Berg Guiang, Engineering Associate and Senior Inspector for the Camrosa Water District, the closest sewer system begins at the City of Camarillo city limits, located approximately 6.5 miles west of the Blanchard Road site.

The Kids' Korral facility consists of a caretaker, garden patch, activity center, turnout corrals, parking structure, and four animal dwellings, including proper housing and a fenced pasture area for miniature horses, Nubian goats, sheep, and ducks. The subsurface sewage disposal system will consist of the installation of two new septic systems. One septic system will consist a 1,000-gallon septic tank and seepage pit, that will treat domestic waste from employees in the caretaker area. The other septic system will consist of a 1,200-gallon septic tank and seepage pit, that will treat domestic waste from visitors at the activity center area. The Discharger has estimated that approximately 700 gallons per day of only domestic wastewater will be discharged from the two proposed septic tank systems.

The Discharger has stated that no more than a dozen animals will be present on the site, including two miniature horses, two goats, two sheep, three ducks, and three rabbits. The Discharger has estimated that these few animals on the 8.75 acres will generate minimal manure. However, the Discharger will properly manage the manure, feed, and bedding, using Best Management Practices (BMPs) in compliance with County Health and County of Ventura Watershed Protection Division's Municipal Separate Storm Sewer Systems (MS4) regulations and guidance.
