Dear Mr. Baker:

In our letter dated September 21, 2005, we informed you that the subject discharge is regulated under Order No. R4-2005-0030, Series No. 015, which specifies your Waste Discharge Requirements (WDR).

In a letter dated July 13, 2009, you notified the Regional Board that the groundwater treatment system was shut down on August 21, 2008 following the completion of groundwater cleanup and you requested termination of the WDR.

The monitoring results were provided to the Regional Board in quarterly monitoring reports. We have reviewed the data and concur with your plan to terminate the WDR. Since you plan to cease the injection of treated groundwater into groundwater aquifer and no longer need the WDR, the coverage under Board Order No. R4-2005-0030, Series No. 015 for the subject facility is hereby terminated effective on July 15, 2009.

The purpose of this letter is to request the Regional Board terminate Tesoro Petroleum Inc.'s General WDR Permit enrollment for the following location:

Facility Name: Former Fast Fuel Site Order No.: R4-2005-0030 CI No.: 8907 Facility ID: 4B198300015

<u>Justification for Permit Termination</u> – The groundwater water treatment system was shutdown on August 21, 2008. Three quarters of post treatment system shutdown monitoring showed no detection of methyl tertiary butyl ether (MTBE) above 5 μ g/L in any groundwater extraction or offsite monitoring well. In a June 3, 2009 meeting Magdy Baiady of the California Regional Water Quality Control Board (CRWQCB) agreed that Tesoro could discontinue groundwater monitoring activities in all extraction and offsite monitoring wells and that the groundwater treatment system could be dismantled.
