TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS— CITY OF LOS ANGELES DEPARTMENT OF TRANSPORTATION, BLOSSOM PLAZA MIXED-USE COMMUNITY, 900 N. BROADWAY, LOS ANGELES, CALIFORNIA (NPDES NO. CAG994004, CI-8946)

Dear Mr. de la Vega:

In our letter dated August 30, 2005, we informed you that the subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On October 1, 2013, City of Los Angeles informed the Regional Board that the City of Los Angeles has concluded all discharges related to the subject project. The City of Los Angeles requested termination of coverage under the above-referenced General NPDES permit.

On October 2, 2013, Regional Board staff inspected the subject facility and verified that there is no discharge of groundwater from the site to surface water. Since there is no discharge of groundwater from the facility, coverage under Board Order No. R4-2008-0032, General NPDES No. CAG994004 is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface water or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate Waste Discharge Requirements.
