TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT – CALFIORNIA STATE UNIVERSITY, LOS ANGELES, PARKING STRUCTURE III, 5151 STATE UNIVERSITY DRIVE, LOS ANGELES (CAG994004, CI-8977)

In our letter dated November 18, 2005, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, General NPDES and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, which also serves as your NPDES permit.

On November 1, 2006, you informed Regional Board staff that your discharge has been diverted to the sanitary sewer. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On November 30, 2006, our staff inspected the facility and verified that there is no discharge to the storm drain.
