TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—CITY OF OXNARD GENERAL SERVICES DEPARTMENT—SANTA CLARA RIVER OUTLET REPAIR PROJECT, OXNARD, CALIFORNIA (NPDES NO. CAG994004, CI-8994)

In our letter dated December 6, 2005, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have received and reviewed your October 28, 2008, letter requesting termination of your coverage under the General Permit. The letter indicated that the subject project was completed in November 2006.

On December 12, 2008, Board staff inspected the project site and verified that there is no discharge of groundwater from the project site to the storm drain. Since there is no discharge of groundwater from the project site, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004, for the subject project is hereby terminated except for enforcement purposes.
