TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—GOLDEN STATE WATER COMPANY, GSWC SAXON NO. 4, 409 EAST SAXON AVENUE, SAN GABRIEL (NPDES CAG994005, CI—9020)

In our letter dated January 25, 2006, we informed you that the subject discharge is regulated under Order No. R4-2003-0108, *General NPDES and Waste Discharge Requirements for Groundwater Discharges from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On March 14, 2007, you informed the Regional Board staff that the above-referenced project was completed in July 2006. On June 15, 2007, our staff inspected the facility, and verified that there is no discharge to the storm drain.

Since there is no discharge from the project to the storm drain, coverage under Board Order No. R4-2003-0108 for the subject facility is hereby terminated except for enforcement purposes. If you have any questions, please contact Vilma Correa at (213) 576-6794.
