

REVISED GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—RHODA FREEMAN 1993 TRUST—5500 EAST ATHERTON STREET OFFICE COMPLEX, 5500 E. ATHERTON STREET, LONG BEACH, CALIFORNIA (NPDES NO. CAG994004, CI-9046)

In our letter dated March 15, 2006, we authorized the discharge of groundwater cleanup wastewater from the above-referenced facility under the National Pollutant Discharge Elimination System (NPDES) General Permit No. CAG994004, Order No. R4-2003-0111; General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties, adopted by this Board on August 7, 2003.

We have received the May 23, 2007, submittal from your consultant, Envent Corporation, requesting to modify the Monitoring and Reporting program No. CI-9046. We have reviewed the influent groundwater data collected from July 2006 through May 2007. The untreated groundwater data indicate that concentrations of volatile organic compounds (VOCs) and lead are non-detect. Therefore, we have no objection to reducing the sampling frequency for VOCs and lead from monthly to annually, on the condition that the treatment system must remain in place and operational for the duration of the permit.

The discharge limitations in Part E.1.a. and 1.c. of Order No. R4-2003-0111 for the specific constituents listed on the Table with the enclosed Fact Sheet are applicable to your discharge. The groundwater discharge flows to Cerritos Channel. Therefore, the discharge limitations listed in Attachment B are not applicable to your discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, <u>ATTN: Information Technology Unit</u>. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-9046 and NPDES No. CAG994004", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.
