
**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—THE NEWHALL LAND AND FARMING COMPANY, SEGMENT C OF VALENCIA COMMERCE CENTER PROJECT, HIGHWAY 126 AND COMMERCE CENTER DRIVE, CASTAIC, CALIFORNIA (NPDES NO. CAG994004, CI-9077)**

In our letter dated May 17, 2006, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, *General NPDES and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On November 13, 2007, you informed Regional Board staff that the above-referenced project was completed on August 24, 2007. Since the NPDES permit is no longer necessary, you requested termination of your coverage under the above-referenced General NPDES permit. On December 18, 2007, Board staff inspected the facility and verified that there is no discharge to the Castaic Creek.

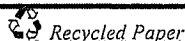
