# WASTE DISCHARGE REQUIREMENTS FOR DISCHARGE OF CONTAMINATED SOIL – SKULL CANYON EXCAVATION SITE, SANTA CATALINA ISLAND, CALIFORNIA (FILE NO. 88-57-034(01))

On September 17, 2001, we received a report of waste discharge (ROWD) from you for the backfill of up to 200 cubic yards of contaminated soil at the subject site. The ROWD was submitted to this Regional Board by Mr. Greg Bishop of EPICS International (EPICS) on your behalf. Subsequently, EPICS submitted additional information about the project to the Regional Board on November 20, 2001.

We have reviewed the information provided, including the total petroleum hydrocarbons, trace metals, volatile organic compounds, and semi-volatile organic compounds analytical data of 13 samples from the waste, and have determined that the proposed backfill of this material meets the conditions specified in Board Order No. 91-93, "General Waste Discharge Requirements for Discharge of Non-Hazardous Contaminated Soils and Other Wastes in Los Angeles River and Santa Clara River Basins", adopted by this Board on July 22, 1991 (attached). This material may be discharged to the place as proposed.

Enclosed are Waste Discharge Requirements, comprising:

- 1. General Waste Discharge Requirements
- 2. Monitoring and Reporting Program

Please note that the Monitoring and Reporting Program requires that a report be submitted to this Board within 10 days of the completion of disposal operations, <u>ATTN: Information Technology</u> <u>Unit.</u> The report shall reference the above file number.

### MONITORING AND REPORTING PROGRAM for DISCHARGE OF NON-HAZARDOUS CONTAMINATED SOILS AND OTHER WASTE

#### SKULL CANYON EXCAVATION SITE SANTA CATALINA ISLAND, CALIFORNIA (FILE NO. 88-57-034(01))

I. Waste Disposal Reporting

- A. A report containing the following information shall be filed with this Regional Board within ten (10) days following completion of all waste disposal:
  - 1. A tabular list of the estimated average quantities (in cubic yards) and types of materials deposited.
  - 2. Where the material was deposited.
  - 3. A certification that all wastes deposited were in compliance with the Regional Board's requirements and that no wastes have been deposited outside of the boundaries of the site as specified in the Regional Board's requirements.
  - 4. In those cases where approval is given for the partial disposal of contaminated soils or other wastes, the ultimate disposal point of the remaining contaminated soils or other wastes must be reported, including the quantity of material disposed of at the different location.
- B. Monitoring reports shall be signed by:
  - 1. In the case of a corporation, by a principal executive officer at least of the level of vice-president or his duly authorized representative, if such representative is responsible for the overall operation of discharge;
  - 2. In the case of a partnership, by a general partner;
  - 3. In the case of a sole proprietorship, by the proprietor;
  - 4. In the case of a municipal, state or other public facility, by either a principal executive officer, ranking elected official, or other duly authorized employee.
