Dear Mr. Eastman:


Our letter dated August 1, 2006, informed you that the subject discharge is regulated under Order No. R4-2005-0030, Series No. 051, and that the Order also served as your Waste Discharge Requirements (WDR).

In a letter dated June 23, 2008, you notified the Regional Board that injection of hydrogen peroxide for the remediation of petroleum hydrocarbons and oxygenates at the site was completed in compliance with the Monitoring And Reporting Program CI-9134 and that you request rescission of the WDR.

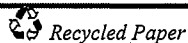
A comparison of pre- and post-hydrogen peroxide injection groundwater data indicated that although initially effective, dissolved phase petroleum hydrocarbon concentrations are consistently elevated. Since hydrogen peroxide has had limited effect, the WDR is no longer needed and the coverage under Order No. R4-2005-0030, Series No. 051 for the subject site is hereby terminated.
