**GENERAL WASTE DISCHARGE REQUIREMENTS FOR GROUNDWATER REMEDIATION
AT PETROLEUM HYDROCARBON FUEL, VOLATILE ORGANIC COMPOUND AND/OR
HEXAVALENT CHROMIUM IMPACTED SITES
FORMER TERRIBLE HERBST STATION #65

Dear Mr. Laszcik:

We have received your application for coverage under the General Waste Discharge Requirements to inject Oxygen Release Compound (ORC) to enhance chemical oxidation and aerobic degradation of dissolved phase petroleum hydrocarbons and fuel oxygenates in the shallow groundwater.

Terrible Herbst, Inc. (hereinafter Discharger) operated a former Terrible Herbst service station #65 at 706 West Harvard Boulevard, Santa Paula, California (Site) (Figure 1) (Latitude: 34° 20' 30", Longitude: 119° 4' 55"). The Site consisted of three 8,000-gallon underground storage tanks (USTs). The USTs were removed in November 1992. Currently, the Site is occupied by a tire repair shop.

Soil and groundwater contaminations with fuel hydrocarbons were found in 1990. A quarterly groundwater monitoring program has been implemented since 1990. The most recent monitoring data indicated that maximum total petroleum hydrocarbon as gasoline (TPH_G) concentration at 7,800 µg/L, benzene concentration at 1,500 µg/L and methyl tertiary butyl ether (MTBE) concentration at 190 µg/L were detected.

An Interim Revised Corrective Action Plan (IRCAP), dated March 29, 2006, prepared by The Westmark Group (WG), was approved by the Ventura County Environmental Health Division (VCEHD) on June 5, 2006.

WG proposes to inject ORC into proposed 27 injection points to 20 feet below ground surface (Figure 2). Existing or future groundwater monitoring wells shall not be used as injection points for application of remediation chemicals, in order to avoid reduction of groundwater monitoring network data bias, well screen clogging and alternation.

We have reviewed the information provided and have determined that the proposed injection meets the conditions specified in Regional Board Order No. R4-2007-0019, "Revised *General Waste Discharge Requirements for Groundwater Remediation at Petroleum Hydrocarbon Fuel*,

The “Monitoring and Reporting Program” requires you to implement the monitoring program on the effective date of this enrollment (March 26, 2007) under Regional Board Order No. R4-2007-0019. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. The WDRs issued will not be rescinded until Regional Board staff determine the WDRs are no longer needed for the site cleanup.

When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to “Compliance File No. CI-9215,” which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.
