TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—MALIBU CREEK PRESERVATION COMPANY, LLC-MALIBU CREEK PLAZA SEPTIC TANK SYSTEMS REPLACEMENT PROJECT, 23359 PACIFIC COAST HIGHWAY, MALIBU, CALIFORNIA (NPDES NO. CAG994004, CI-9231)

In our letter dated February 26, 2007, we informed you that the subject discharge is regulated under Order No. R4-2003-0111, *Waste Discharge Requirements for Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003, which also serves as your NPDES permit.

We have reviewed the June 20, 2008, letter from your consultant, Pure Effect, Inc., requesting termination of your coverage under the General Permit. The letter indicated that you completed the dewatering project on April 17, 2007, and that you have ceased discharging treated groundwater.

On June 24, 2008, Board staff inspected the project site and verified that there is no discharge of groundwater from the site to the Malibu Creek. Since there is no discharge of groundwater from the site, coverage under Board Order No. R4-2003-0111, General NPDES Permit No. CAG994004, for the subject site is hereby terminated except for enforcement purposes.

Please note that if future discharge of any groundwater to surface water become necessary at the site, you must file a Report of Waste Discharge with this Board and appropriate obtain waste discharge requirements.
