## TERMINATION OF GENERAL WASTE DISCHARGE REQUIREMENTS AT VENTURA WEST CAR WASH, 22517 VENTURA BOULEVARD WOODLAND HILLS, CALIFORNIA (ORDER NO. R4-2007-0019, SERIES NO. 020, CI-9282)

Dear Mr. Emein and Mr. Aminpour:

In our letter dated July 10, 2007, we informed you that the subject discharge is regulated under Order No. R4-2007-0019, (Series No. 020), which specifies your Waste Discharge Requirements (WDR).

In the monitoring report dated September 12, 2008, you notified the Regional Board that you ceased oxidizing/colloid agents injection for this site and that you requested termination of the WDR.

Because the ongoing remediation does not plan to continue to inject oxidizing/colloid agents, you no longer need the WDR. The coverage under Board Order No. R4-2007-0019, (Series No. 020), for the subject facility is hereby terminated with the exception of enforcement under the term of the permit.
