**TERMINATION OF COVERAGE UNDER GENERAL WASTE DISCHARGE REQUIREMENTS  
– 76 STATION NO. 6267, 23670 PACIFIC COAST HIGHWAY, MALIBU, CALIFORNIA  
(ORDER NO. R4-2007-0019, CI-9326, SERIES NO. 036)  
UNDERGROUND STORAGE TANK (UST) CASE NO. I-00097A (PRIORITY D-1, EAOP)**

Dear Mr. Mosconi:


In our letter dated September 28, 2007, we informed you that the subject discharge is regulated under Order No. R4-2007-0019, Series No. 016, which specifies your Waste Discharge Requirements (WDR).

In a letter dated June 12, 2009, you notified the Regional Board that injection of ozone for remediation of petroleum hydrocarbons and fuel oxygenates at the site will not be performed, and that you requested termination of the WDR.

The monitoring results were provided to the Regional Board in quarterly monitoring reports. Since you will not initiate the ozone injection and you no longer need the WDR permit, the coverage under Board Order No. R4-2007-0019, Series No. 036, for the subject facility is hereby terminated. Please note that you would be required to re-apply for a WDR for similar future in-situ remedial activities, if any, for the subject site. To switch to air injection, you shall submit a revised remedial action plan (RAP). Semi-annual groundwater monitoring requirements identified in our letter dated June 15, 2009 remain in effect.
