TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS—
CALLEGUAS MUNICIPAL WATER DISTRICT, SALINITY MANAGEMENT PIPELINE, PHASE 1E, HYDROSTATIC TEST PROJECT, EAST HUENEME RD TO PORT HUENEME, OXNARD, CALIFORNIA (NPDES NO. CAG674001, CI-9391)

Dear Ms. Mulligan:

In our letter dated September 8, 2009, we informed you that the subject discharge is regulated under Order No. R4-2009-0068, *Waste Discharge Requirements for Discharges of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On June 19, 2012, Calleguas Municipal Water District (CMWD) informed the Regional Board that CMWD has concluded all discharges related to the subject project. Since the NPDES permit is no longer necessary, CMWD requested termination of coverage under the above-referenced General NPDES permit.

On August 10, 2012, Regional Board staff inspected the subject project and verified that there is no discharge of hydrostatic test water to surface water. Therefore, coverage under Board Order No. R4-2009-0068 for the subject project is hereby terminated, except for enforcement purposes.

Please note that if future discharges of hydrostatic test water to surface water or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate Waste Discharge Requirements.
