**TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—2126 STRAND LLC, SINGLE FAMILY HOUSE, 2126 THE STRAND, HERMOSA BEACH, CALIFORNIA (NPDES NO. CAG994004, CI-9443)**

In our letter dated August 19, 2008, we informed you that the subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 5, 2008, which also serves as your NPDES permit.


We have reviewed your June 23, 2009, letter requesting termination of your coverage under the General Permit. The letter indicated that you have completed your construction project and ceased groundwater discharge.

On September 24, 2009, Board staff inspected the project site and verified that there is no discharge of groundwater from the site to surface waters. Since there is no discharge of groundwater from the site, coverage under the Board Order No. R4-2008-0032, General NPDES Permit No. CAG994004, for the subject site is hereby terminated except for enforcement purposes.

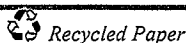
Please note that if future discharges of groundwater to surface waters become necessary, you must file a Report of Waste Discharge with this office and obtain appropriate Waste Discharge Requirements (WDRs).

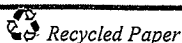
