TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT AND WASTE DISCHARGE REQUIREMENTS- CITY OF GLENDORA, CITY WELL NO. 14, 1221 EAST LEADORA AVENUE, GLENDORA, CALIFORNIA (NPDES NO. CAG994005, CI-9527)

Dear Mr. Davies:

In our letter dated August 13, 2009, we informed you that the subject discharge is regulated under Order No. R4-2003-0108, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Discharges of Groundwater From Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, which also serves as your NPDES permit.

On September 25, 2013, City of Glendora informed the Regional Board that the City of Glendora has concluded all discharges related to the subject project. City of Glendora requested termination of coverage under the above-referenced General NPDES permit.

On October 25, 2013, Regional Board staff inspected the subject project and verified that there is no discharge of groundwater from the site to surface water. Since there is no discharge of groundwater from the facility, coverage under Board Order No. R4-2003-0108, General NPDES No. CAG994005 is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface water or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate Waste Discharge Requirements.
