TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—OAK TREE CONSTRUCTION, INC.—PARADISE COVE STORMWATER TREATMENT FACILITY PROJECT, 28128 PACIFIC COAST HIGHWAY, MALIBU, CALIFORNIA (NPDES NO. CAG994004, CI-9570)

The subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System Permit and Waste Discharges of Groundwater From Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on July 8, 2008.

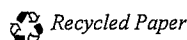
We have reviewed your June 25, 2010, letter which requested termination of your coverage under the General NPDES Permit. The letter indicated that you have completed the construction project and that you have stopped the groundwater discharge to storm drain.

As indicated to you in our July 7, 2010, correspondence Regional Board staff has conducted and completed the compliance history review for your facility. Based on the review, no outstanding mandatory minimum penalty violation exist for your facility. Therefore, your permit has been cleared for termination.

On August 26, 2011, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to the storm drain. Since there is no discharge of groundwater from the facility, coverage under Board Order No. R4-2008-0032, General NPDES Permit No. CAG994004, for the facility is hereby terminated.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.


