GENERAL WASTE DISCHARGE REQUIREMENTS FOR GROUNDWATER CLEANUP AT PETROLEUM HYDROCARBON FUEL, VOLATILE ORGANIC COMPOUND AND/OR HEXAVALENT CHROMIUM IMPACTED SITES (ORDER NO. R4-2007-0019) U.S. POSTAL SERVICE, 5823 WHITE OAK AVENUE, ENCINO, CALIFORNIA (CI-9661, SERIES NO. 149); (UST FILE NO. 913160225)

Dear Mr. Kadara:

We have completed our review of your application for coverage under General Waste Discharge Requirements (WDR) for Fenton's Reagent (RegenOxTM) and Oxygen Release Compound (ORC®) application at the subject Site. The purpose of the injection is to mitigate fuel constituents present in soil and groundwater beneath the Site in order to minimize the threat to the underlying aquifers.

The United States Postal Service (hereinafter Discharger) owns the facility (Site) located at the corner of White Oak Avenue and Hatteras Avenue in Encino, California (Figure 1) (Latitude: N 34° 10' 35.64", Longitude: W 118° 31' 6.7"). The Site formerly contained five underground storage tanks (USTs). The Site is currently an operating Encino Post Office.

In April 1986, five USTs were removed from the Site. Site investigations found that the soil and groundwater beneath the Site have been impacted by fuel constituents. Periodic groundwater monitoring program was initiated in December 1997. The most recent monitoring data (December 2009) showed the maximum total petroleum hydrocarbons as gasoline (TPH_G) concentration at 56,000 $\mu g/L$ and benzene at 4,100 $\mu g/L$.

In a remedial action plan (RAP) dated April 16, 2010, the Discharger's consultant, TRC proposes to mitigate the contaminated soil and groundwater beneath the Site by utilizing In-situ Chemical Oxidation (ISCO) technology in conjunction with enhanced, aerobic biodegradation. TRC proposes to inject RegenOxTM and ORC® into the subsurface to enhance biodegradation of petroleum hydrocarbons in the groundwater (Figure 2). The RegenOxTM is a sodium percarbonate/catalytic formulation. In a Regional Board staff directive letter dated May 11, 2010, the RAP was approved.

Regional Board staff has determined that the proposed discharge meets the conditions specified in Order No. R4-2007-0019, "Revised General Waste Discharge Requirements for Groundwater Remediation at Petroleum Hydrocarbon Fuel, Volatile Organic Compound and/or Hexavalent Chromium Impacted Site (General WDRs)" adopted by the Los Angeles Regional Water Quality Control Board on March 1, 2007.

Enclosed are the Waste Discharge Requirements, consisting of Regional Board Order No. R4-2007-0019, Monitoring and Reporting Program No. CI-9661, and Standard Provisions.

The WDRs issued shall not be terminated until Regional Board staff determines the WDRs are no-longer needed for the site cleanup.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of this enrollment under Regional Board Order No. R4-2007-0019. All monitoring reports shall be sent to the Regional Board, <u>ATTN: Information Technology Unit.</u>

When submitting monitoring or technical reports to the Regional Board, please include a reference to Compliance File No. CI-9661 to assure that the reports are directed to the appropriate staff. Do not combine other reports with your monitoring reports complying with Order No. R4-2007-0019. Submit each type of report as a separate document.

We are sending a copy of Order No. R4-2007-0019 only to the applicant. A copy of the Order will be furnished to anyone who requests it. To avoid paying future annual fees, please submit written request for termination of your enrollment under the general permit in a separate letter, when your project has been completed and the permit is no longer needed. Be aware that the annual fee covers the fiscal year billing period beginning July 1 and ending June 30, the following year. You will pay the full annual fee if your request for termination is made after the beginning of the new fiscal year beginning July 1.

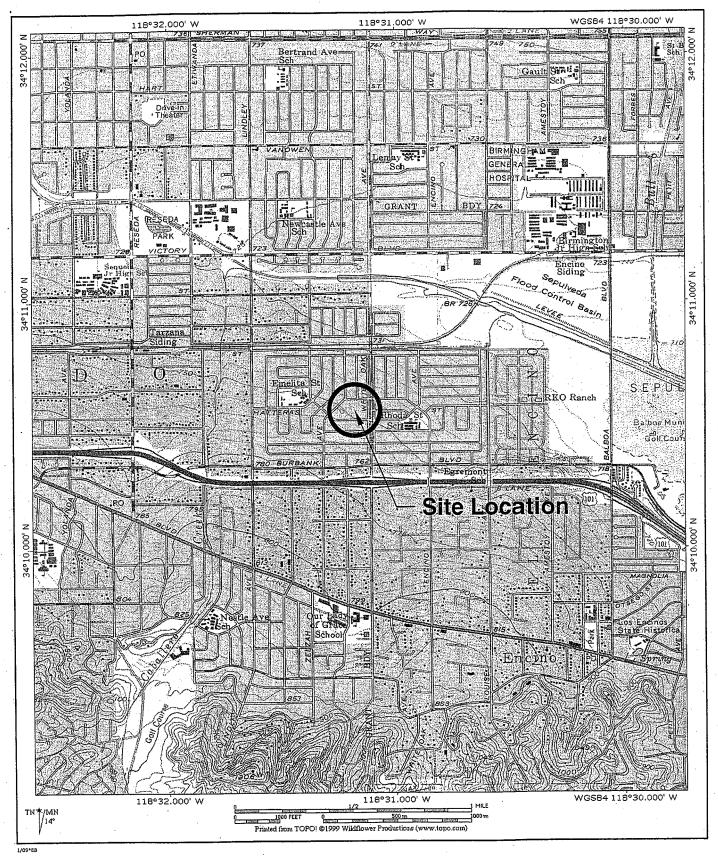

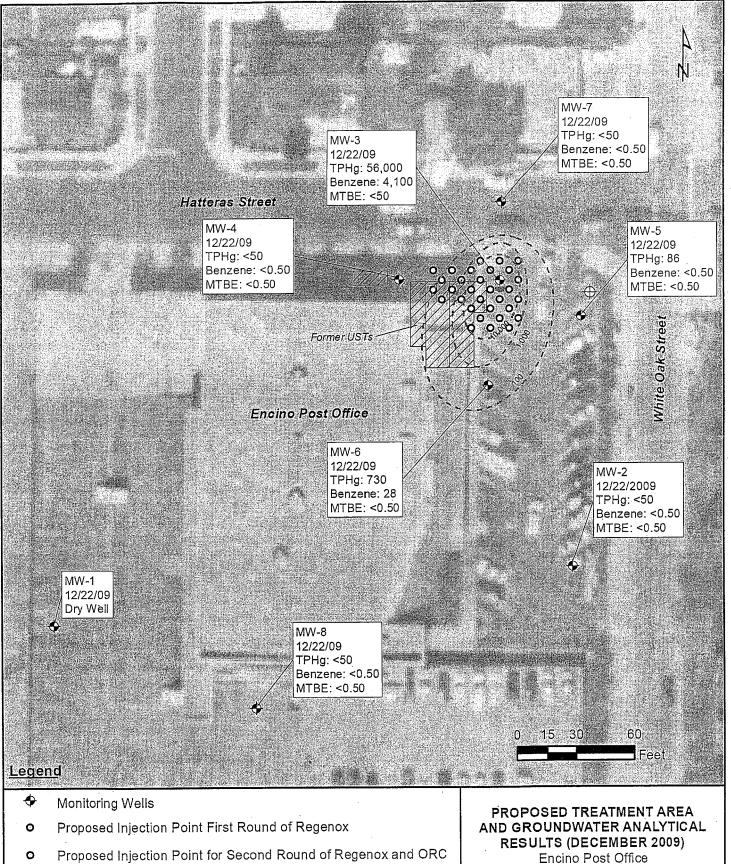

I. REPORTING REQUIREMENTS

A. United States Postal Service (hereinafter Discharger) shall implement this monitoring program on the effective date of Regional Board Order No. R4-2007-0019. The first monitoring report under this program, for January - June 2011, shall be received at the Regional Board by **July 15, 2011**. Subsequent monitoring reports shall be received at the Regional Board according to the following schedule:

- B. If there is no discharge or injection during any reporting period, the report shall so state. Monitoring reports must be addressed to the Regional Board, Attention: <u>Information Technology Unit</u>.
- C. By March 1 of each year, the Discharger shall submit an annual summary report to the Regional Board. The report shall contain both tabular and graphical summaries of the monitoring data obtained during the previous calendar year. In addition, the Discharger shall explain the compliance record and the corrective actions taken or planned, which may be needed to bring the discharge into full compliance with the waste discharge requirements (WDR).
- D. Laboratory analyses all chemical, bacteriological, and toxicity analyses shall be conducted at a laboratory certified for such analyses by the California Department of Health Services Environmental Laboratory Accreditation Program (ELAP). A copy of the laboratory certification shall be provided each time a new and/or renewal certification is obtained from ELAP.
- E. The method limits (MLs) employed for effluent analyses shall be lower than the permit limits established for a given parameter, unless the Discharger can demonstrate that a particular ML is not attainable and obtains approval for a higher ML from the Regional Board Executive Officer (Executive Officer). The Discharger shall submit a list of the

analytical methods employed for each test and the associated laboratory quality assurance/quality control (QA/QC) procedures upon request by the Regional Board.

- F. Groundwater samples must be analyzed within allowable holding time limits as specified in 40 CFR Part 136. All QA/QC samples must be run on the same dates when samples were actually analyzed. The Discharger shall make available for inspection and/or submit the QA/QC documentation upon request by Regional Board staff.
- G. Each monitoring report must affirm in writing that "All analyses were conducted at a laboratory certified for such analyses by the California Department of Health Services, and in accordance with current United States Environmental Protection Agency (USEPA) guideline procedures or as specified in this Monitoring Program." Proper chain of custody procedures must be followed and a copy of the completed chain of custody form shall be submitted with the report.
- H. Each monitoring report shall contain a separate section titled "Summary of Non-Compliance" which discusses the compliance record and the corrective actions taken or planned that may be needed to bring the discharge into full compliance with WDRs. This section shall be located at the front of the report and shall clearly list all non-compliance with WDRs, as well as all excursions of effluent limitations.
- I. The Discharger shall maintain all sampling and analytical results: date, exact place, and time of sampling; dates analyses were performed; analyst's name; analytical techniques used; and results of all analyses. Such records shall be retained for a minimum of three years. This period of retention shall be extended during the course of any unresolved litigation regarding this discharge, or when requested by the Regional Board.
- J. If the Discharger performs analyses on any groundwater samples more frequently than required by this Order using approved analytical methods, the results of those analyses shall be included in the report.
- K. In reporting the monitoring data, the Discharger shall arrange the data in tabular form so that the date, the constituents, and the concentrations are readily discernible. The data shall be summarized to demonstrate compliance with the requirements and, where applicable, shall include results of receiving water observations.
- L. The Discharger should not implement any changes to the Monitoring and Reporting Program prior to receiving Executive Officer's written approval.

II. <u>DISCHARGE MONITORING REQUIREMENTS</u>

The semi-annual reports shall contain the following information regarding the injection activities.

- 1. Location map showing injection points used for the injection activities.
- 2. Written and tabular summary defining:

- Depth of injection points;
- · Quantity of Fenton's Reagent and ORC injected at each injection point;
- Days on which the injection system was in operation; and
- Total amount of Fenton's Reagent and ORC injected at the site.
- 3. Semi-annual visual inspection at each injection well shall be conducted to evaluate the well casing integrity after each injection. The semi-annual report shall include a summary of the visual inspection.
- 4. To avoid groundwater monitoring network reduction, data bias, and well screen clogging or alteration, no groundwater monitoring wells shall be used as injection points during the proposed Fenton's Reagent injection. Separate injection points/wells must be installed at the Site for the proposed Fenton's Reagent/ORC injection.

III. GROUNDWATER MONITORING PROGRAM

A groundwater-monitoring program shall be designed to detect and evaluate impacts associated with the injection activities. The monitoring well network must include MW-4, MW-7 as upgradient wells; MW-3 as source well; and MW-2, MW-5 and MW-6, as downgradient wells. A baseline monitoring and sampling shall be conducted prior to the proposed injections. Baseline monitoring will establish the initial conditions with respect to the contaminant levels. These sampling stations shall not be changed and any proposed change of monitoring locations shall be identified and approved by the Regional Board Executive Officer (Executive Officer). The Discharger shall conduct a baseline sampling from all wells onsite one or two weeks prior to the proposed injection and regular sampling with the required frequencies from all the monitoring wells in the monitoring network for the following constituents:

Field instrument may be used to measure this parameter.

The Discharger is required to monitor for total chromium and chromium six in the baseline, second and fourth semi-annual sampling. If detected at any of these sampling events, the total chromium and chromium six must be monitored semi-annually thereafter.

All groundwater monitoring reports must include, at a minimum, the following:

- a. Well identification, date and time of sampling;
- b. Sampler identification, and laboratory identification;
- c. Semi-annual observation of groundwater levels, recorded to 0.01 feet mean sea level and groundwater flow direction.

IV. MONITORING FREQUENCIES

Specifications in this monitoring program are subject to periodic revisions. Monitoring requirements may be modified or revised by the Executive Officer based on review of monitoring data submitted pursuant to this Order. Monitoring frequencies may be adjusted to a less frequent basis or parameters and locations dropped by the Executive Officer if the Discharger makes a request and the request is backed by statistical trends of monitoring data submitted.

Each report shall contain the following completed declaration:

"I certify under penalty of law that this document, including all attachments and supplemental information, was prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gathered and evaluated the information submitted. Based on my inquiry of the person or persons who manage the system, or those persons directly responsible for gathering the information, the information submitted is, to the best of my knowledge and belief, true, accurate, and complete. I am aware that there are significant penalties for submitting false information, including the possibility of a fine and imprisonment".
