TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—LOS ANGELES COUNTY DEPARTMENT OF PUBLIC WORKS, COMMERCE CENTER DRIVE INTERCHANGE, PART I, COMMERCE CENTER DR. & HENRY MAYO DR. INTERSECTION, VALENCIA, CALIFORNIA (NPDES NO. CAG994004, CI-9692)

The subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 5, 2008.

We have reviewed the email from Mr. Oscar Enriquez of your office dated July 24, 2014, requesting termination of your coverage under the General Permit. The letter indicated that you have stopped discharging from the above-referenced facility to surface water and that the subject NPDES permit is no longer needed.

On October 23, 2014, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to surface water. Since there is no discharge of groundwater from the facility, coverage under Board Order R4-2008-0032, General NPDES Permit No. CAG994004 for the facility is hereby terminated, except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
