TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—EL SEGUNDO POWER, LLC, EL SEGUNDO OPERATIONS INC. POWER PLANT, 301 VISTA DEL MAR, EL SEGUNDO, CALIFORNIA (NPDES NO. CAG674001, CI-9775)

Dear Mr. Riesz, Sr.:

The subject discharge is regulated under Order No. R4-2009-0068, *Waste Discharge Requirements and General National Pollutant Discharge Elimination System Permit for Discharges of Low Threat Hydrostatic Test Water to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 4, 2009.

We have reviewed your letter dated March 27, 2013, requesting termination of your coverage under the General Permit. The letter indicated that you have stopped discharging from the above-referenced facility to surface water and that the subject NPDES permit is no longer needed.

On April 4, 2013, Board staff inspected the project site and verified that there is no discharge of hydrostatic test water from the facility to surface water. Since there is no discharge of hydrostatic test water from the facility, coverage under Board Order R4-2009-0068, General NPDES Permit No. CAG674001 for the facility is hereby terminated, except for enforcement purposes.

Please note that if future discharges of hydrostatic test water to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
