POSTPONEMENT OF BOARD HEARING DATE—TENTATIVE WASTE DISCHARGE REQUIREMENTS – GENERAL NPDES PERMIT FOR DISCHARGES FROM POTABLE WATER SUPPLY SYSTEMS TO SURFACE WATERS IN COASTAL WATERSHEDS OF LOS ANGELES AND VENTURA COUNTIES (GENERAL NPDES PERMIT NO. CAG994005)

On March 5, 2008, we mailed all the interested parties the tentative Waste Discharge Requirements and General National Pollutant Discharge Elimination System Permit for Discharges (NPDES) from Potable Water Supply Systems to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties.

In that letter we mentioned that the draft permit was scheduled for consideration at the May 1, 2008, Board meeting. Due to requests for postponement and other comments received on the tentative permit, we are postponing the consideration of this permit at the Board meeting to a future date. In the interim, Regional Board staff will consider all the comments received and, where appropriate, will modify the tentative permit to address the comments. We will notify you of the future Board Hearing date for this tentative permit in a separate letter.

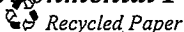

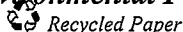

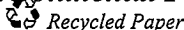
