POSTPONEMENT OF CONSIDERATION FOR ADOPTION OF TENTATIVE WASTE DISCHARGE REQUIREMENTS—GENERAL NPDES PERMIT FOR DISCHARGES FROM POTABLE WATER DISTRIBUTION AND WATER SUPPLY SYSTEMS TO SURFACE WATERS IN COASTAL WATERSHEDS OF LOS ANGELES AND VENTURA COUNTIES (GENERAL NPDES PERMIT NO. CAG994005)

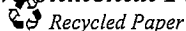

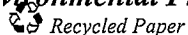
