REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS (WDRs) AND WATER RECLAMATION REQUIREMENTS (WRRs) AND RESPONSE TO COMMENTS FOR THE CITY OF SANTA MONICA, SUSTAINABLE WATER INFRASTRUCTURE PROJECT (SWIP) (FILE NO. 20-090, CI-10569)

Dear Mr. Wang:

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) staff has revised the tentative Waste Discharge Requirements (WDRs) and Water Reclamation Requirements (WRRs) dated December 14, 2020, based on comments received by the January 13, 2021 public comment deadline. A copy of the revised tentative order and written responses to all comments received are enclosed. Changes to the tentative WDRs and WRRs appear in strikeout and underline format. Written comments are not being solicited regarding the revised tentative order.

In accordance with administrative procedures, the Los Angeles Water Board, at a public hearing to be held on **February 11, 2021, at 9:00 a.m., in a virtual meeting**, will consider the enclosed revised tentative requirements and comments submitted in writing regarding the revised tentative order. It is expected the Board will take action at the hearing; however, as testimony indicates, the Board, at its discretion, may order further action by staff.
