TENTATIVE TERMINATION OF WASTE DISCHARGE REQUIREMENTS - MANNING PIT INERT LANDFILL, IRWINDALE, CALIFORNIA (FILE NO. 61-101, ORDER NO. R4-2002-0103, CI-6149, GEOTRACKER GLOBAL ID L10002323364)

Dear Mr. Tam:

The California Regional Water Quality Control Board, Los Angeles Region (Regional Water Board) adopted Waste Discharge Requirements (WDRs) Order No. R4-2002-0103 on May 23, 2002, for the Manning Pit Inert Landfill (Landfill) in Irwindale, California. On April 11, 2019, the City of Irwindale (Discharger), submitted a report to the Regional Water Board, requesting termination of the WDRs. Because the permitted discharge of wastes at the site has ceased, Regional Water Board staff intends to terminate the WDRs.

In accordance with administrative procedures, this Regional Water Board, at a public hearing, will consider the enclosed tentative Order, which will terminate WDRs Order No. R4-2002-0103. The hearing will be held on **September 12, 2019**, at the City of Simi Valley Council Chambers, 2929 Tapo Canyon Drive, Simi Valley, California, and will begin at 9:00 AM.

In order to be fully evaluated by Regional Water Board staff and included in the Board's agenda packet, written comments must be received at the Regional Water Board office by 5:00 PM on **August 15, 2019**. Failure to comply with these requirements is grounds for the Regional Water Board to refuse to admit the proposed written comments or exhibits into evidence. Timely submittal of written comments is encouraged to ensure that all comments are accurately and fully included in the administrative record, that Regional Water Board staff is able to provide a timely review, and that Regional Water Board members have sufficient time to give full consideration to the comments and issues raised.
