## CHANGE OF VENUE NOTIFICATION FOR THE TENTATIVE AMENDMENT TO WASTE DISCHARGE REQUIREMENTS (WDRs) FOR PORT OF LONG BEACH MIDDLE HARBOR REDEVELOPMENT PROJECT (FILE NO. 09-204)

Dear Mr. Arms,

On April 9, 2019, the California Regional Water Quality Control Board, Los Angeles Region (Regional Water Board) transmitted the tentative Waste Discharge Requirements (WDRs) for Port of Long Beach Middle Harbor Redevelopment Project to allow the use of the Slip 3 borrow area as a disposal site for the material that accumulates in the East Basin. No comments were received pertaining to the tentative WDRs. The April 9<sup>th</sup> letter also informed you that the June Board meeting would be located at the Port of Long Beach. The purpose of this letter is to notify you that the venue for the June Board meeting has been changed to the **City of Camarillo, 601 Carmen Drive, Camarillo, California.** The date and time of the public hearing remain the same.

In accordance with administrative procedures, the Los Angeles Regional Water Quality Control Board at a public meeting to be held on **June 13, 2019, at 9:00 a.m.**, at the **City of Camarillo, 601 Carmen Drive, Camarillo, California.**, will consider the previously distributed Tentative Amendment. The Board will hear any testimony pertinent to these discharges and the tentative requirements. It is expected that the Board will take action at the hearing; however, as testimony indicates, the Board at its discretion may order further investigation.
