#### **NOTICE OF OPPORTUNITY FOR PUBLIC COMMENTS AND PUBLIC MEETING – TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR PIRU WASTEWATER TREATMENT PLANT, LOCATED AT 2815 EAST TELEGRAPH ROAD, PIRU, CALIFORNIA 93015 (FILE NO. 08-164, ORDER NO. R4-2023-XXXX, CI-5714, GLOBAL ID WDR100000084)**

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will hold a public meeting to consider a tentative order renewing Waste Discharge Requirements (WDRs) Order No. R4-2014-0188, which was adopted on September 11, 2014, for the discharge of treated domestic wastewater from the Trancas Water Pollution Control Plant.
