TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS FOR THE PIRU WASTEWATER TREATMENT PLANT, LOCATED AT 2815 EAST TELEGRAPH ROAD, PIRU, CALIFORNIA 93015 (FILE NO. 08-164, ORDER NO. R4-2023-XXXX, CI-5714, GLOBAL ID WDR100000084)

Dear Joseph Pope:

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) is the public agency with primary responsibility for the protection of ground and surface water quality for all beneficial uses of water within major portions of Los Angeles and Ventura Counties, including the facility mentioned above.

We have completed our review of your updated Report of Waste Discharge and have prepared a tentative revised Waste Discharge Requirements (WDRs) for the Piru Wastewater Treatment Plant.

Enclosed are copies of the tentative WDRs consisting of:

- a. Tentative revised Regional Water Board Order No. R4-2023-XXXX;
- b. Tentative revised MRP No. CI-5714; and
- c. Attachments A to D, including Maximum Contaminant Levels and Standard Provisions Applicable to WDRs.

In accordance with administrative procedures, the Los Angeles Water Board is scheduled to consider the enclosed tentative WDRs and public comments timely received for a public hearing to be held at 9:00 a.m. on June 22, 2023, at the Junipero Serra Building (Carmel Room), 320 West 4th Street, Los Angeles, California, 90013. A virtual platform is also available for those who would like to join the meeting online. Please follow the directions provided in the agenda to register or to view the Board meeting online. The Los Angeles Water Board will hear any testimony pertinent to this discharge and the

tentative discharge requirements. It is expected that the Los Angeles Water Board will take action at the hearing; however, the Los Angeles Water Board at its discretion may order further investigation if the testimony at the meeting warrants it.

In order to be evaluated by Los Angeles Water Board staff and included in the Los Angeles Water Board members' agenda packets, written comments or evidence regarding these tentative WDRs must be received at the Los Angeles Water Board's office by **5:00 p.m. on May 31, 2023**. Failure to comply with these requirements is grounds for the Los Angeles Water Board to refuse to admit the proposed written comment or evidence into the record. Timely submittal of written comments is required to ensure that all comments are accurately and fully included in the administrative record, that Los Angeles Water Board staff is able to provide timely review and time to respond to comments, and that Los Angeles Water Board members have sufficient time to give full consideration to the comments and issues raised.

The agenda for the meeting will be posted on the Los Angeles Water Board's website (<a href="https://www.waterboards.ca.gov/losangeles/board\_info/agenda/">https://www.waterboards.ca.gov/losangeles/board\_info/agenda/</a>) approximately 10 days prior to the meeting.
