The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will hold a public meeting to consider a tentative order renewing Waste Discharge Requirements (WDRs) Order No. R4-2014-0188, which was adopted on September 11, 2014, for the discharge of treated domestic wastewater from the Trancas Water Pollution Control Plant.
