The information gained by the City through participation may be used to evaluate whether the discharge impacts kelp beds near the outfall."

"The Discharger shall participate in the management and technical committee's responsibility for the final survey design and shall provide appropriate financial support to help fund the survey (share base) on the number of participates in the study, but not to exceed a maximum of \$10,000 per year."
