To support recycling, monthly performance data through July 2018 was evaluated. Based on this evaluation, the ammonia performance goal was revised from 43.8 mg/L to 51.8 mg/L, which represent the 99 <sup>th</sup> percentile effluent concentration. The Ocean Plan based effluent limit, when dilution is considered, would be 65 mg/L. The previous performance goal was 49.13 mg/L.	Revisions were made to the permit.
