NOTICE OF PUBLIC HEARING

PROPOSED ISSUANCE OF WASTE DISCHARGE REQUIREMENTS (WDRs) AND NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT

The Joint Outfall System (hereinafter Discharger) owns and operates the Joint Water Pollution Control Plant (JWPCP) and its associated wastewater collection system and outfalls. JWPCP currently receives wastewater from the six upstream water reclamation plants - La Cañada, Whittier Narrows, San Jose Creek, Pomona, Los Coyotes and Long Beach. The wastewater is a mixture of domestic wastewater and industrial wastewater that is pretreated.

The JWPCP is a secondary wastewater treatment plant with a monthly average daily dry weather treatment capacity of 400 million gallons per day (MGD). Treatment at the JWPCP consists of preliminary treatment (bar screening and grit removal), primary treatment (primary sedimentation and scum removal), secondary treatment (pure oxygen activated sludge biological reactors and secondary clarification), and disinfection with sodium hypochlorite. The solid waste produced at JWPCP is either hauled off to a landfill or anaerobically digested on-site to generate class B biosolids for composting and land applications. JWPCP also accepts liquid and solid food waste slurry generated from processing food waste. The liquid food waste slurry is mixed with incoming sewage before entering bar screens and the solid food waste slurry is anaerobically digested at JWPCP.

The discharge is regulated under WDRs contained in Order Number R4-2017-0180, adopted by the California Regional Water Quality Control Board Los Angeles Region (Los Angeles Water Board), on September 7, 2017. Order Number R4-2017-0180 serves as a permit under the National Pollutant Discharge Elimination System (NPDES Number CA0053813). The Discharger filed a report of waste discharge (ROWD) and applied for reissuance of its WDRs and NPDES permit on May 4, 2022, to discharge secondary-treated effluent to the Pacific Ocean. Los Angeles Water Board staff requested additional information on May 27, 2022 and the additional information was received on June 30, 2022. The application was deemed complete on July 6, 2022. The

terms and conditions of the current NPDES order have been automatically continued and remain in effect until new WDRs and NPDES permit are adopted pursuant to this Order.

On the basis of preliminary staff review and application of lawful standards and regulations, the Los Angeles Water Board, tentatively proposes to issue consolidated WDRs and NPDES permit under Title 40 of the Code of Federal Regulations (40 CFR) § 124.4(c)(2).

Interested persons are invited to attend. At the public hearing, the Los Angeles Water Board will hear any testimony pertinent to the discharge, tentative WDRs, and NPDES permit. Oral testimony will be heard; however, for accuracy of the record, important testimony should be in writing.

during the hearing. The entire file will not be present in the hearing room. Should any interested persons desire staff to bring to the hearing any documents that are not included in the agenda packet, they must submit a written or electronic request to staff during business hours, not later than five business days before the hearing. The request must identify the documents with enough specificity for staff to locate them.

NATURE OF HEARING

This will be a formal adjudicative hearing pursuant to section 648 et seq. of title 23 of the California Code of Regulations. Chapter 5 of the California Administrative Procedure Act (commencing with section 11500 of the Government Code) will not apply to this proceeding.

Ex Parte Communications Prohibited: As a quasi-adjudicative proceeding, no board member may discuss the subject of this hearing with any person, except during the public hearing itself. Any communications to the Los Angeles Water Board must be directed to staff.

Persons wishing to comment on, or object to, the tentative WDRs and NPDES permit, or submit evidence for the Board to consider, are invited to submit them in writing to Dr. Don Tsai at Don.Tsai@waterboards.ca.gov. To be evaluated and responded to by Los Angeles Water Board staff, included in the Board's agenda folder, and fully considered by the Board, written comments or testimony regarding the tentative must be received no later than **5:00 p.m. on May 1, 2023**. Failure to comply with these requirements is grounds for the Los Angeles Water Board to refuse to admit the proposed written comment or exhibit into evidence pursuant to section 648.4, title 23 of the California Code of Regulations.

HEARING PROCEDURE

The Board meeting, of which this hearing is a part, will start at 9:00 a.m. Interested persons are invited to attend. When the agenda item is called, staff will present the matter under consideration, after which oral statements from parties or interested persons will be heard. For accuracy of the record, all important testimony should be in writing. The Board will include in the administrative record written transcriptions of oral testimony that is actually presented at the hearing. Oral testimony may be limited to five minutes or less for each interested person, depending on the number of interested persons wishing to be heard.

Parties or interested persons with similar concerns or opinions are encouraged to choose one representative to speak and are encouraged to coordinate their presentations with each other. Parties will be advised after the receipt of public comments, but prior to the date of the hearing, of the amount of time each is allocated for presentations. That decision will be based upon the complexity and number of issues under consideration, the extent to which the parties have coordinated, the number of parties and interested persons anticipated, and the time available for the hearing. The parties are invited to contact staff not later than **May 10, 2023**, to discuss how much time they believe is necessary for their presentations, and staff will endeavor to accommodate reasonable requests. At the conclusion of testimony, the Board will deliberate in open or close session, and render a decision.

The Board does not generally require the prior identification of witnesses, the cross examination of witnesses, or other procedures not specified in this notice. Parties or persons with special procedural requests or requests for alternative hearing procedures should contact staff, who will endeavor to accommodate reasonable requests. Objections to any procedure to be used during this hearing must be submitted in writing no later than close of business 15 business days prior to the date of the hearing. (Any objections related to the amount of time allocated for parties' presentations must be submitted within two business days of notice thereof, if that date is less than 15 business days before the hearing.) Absent such objections, any procedure not specified in this hearing notice will be waived pursuant to section 648(d) of title 23 of the California Code of Regulations. Procedural objections will not be entertained at the hearing.

If there should not be a quorum on the scheduled date of this meeting, all cases will be automatically continued to the next scheduled meeting on **June 22, 2023**. A continuance will not extend any time set forth herein.
